Recall Campaign No. 14V-211 2013 R 1200 GS – Gearbox Sealing Ring

Dear BMW Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

BMW AG has decided that a defect, which relates to motor vehicle safety, exists in certain Model Year 2013 R 1200 GS motorcycles. Our records indicate that you are the owner of an affected motorcycle.

DESCRIPTION OF PROBLEM

This recall involves the gearbox sealing ring. Due to the possibility of high pressure within the gearbox, the sealing ring could be pushed out from its seated position. If this happened, oil could leak onto the rear tire.

If oil leaked onto the rear tire, this could adversely affect handling and increase the risk of a crash.

- 1. PLEASE CONTACT YOUR AUTHORIZED BMW MOTORCYCLE DEALER IMMEDIATELY TO HAVE THE NECESSARY REPAIR PERFORMED AS SOON AS POSSIBLE.
- 2. If you notice oil around the gearbox, swing arm or on the rear tire, the motorcycle may be experiencing this condition. Carefully move away from traffic and pull over to a safe location as soon as possible. Shut off the engine. Do not continue to ride your motorcycle. Contact BMW Motorcycle Roadside Assistance at 1-877-680-2176 to have your motorcycle brought to the nearest authorized BMW dealer.
- 3. If you are not the only rider of this motorcycle, please advise all other riders of this important information.

DESCRIPTION OF REPAIR

A bracket will be installed that secures the sealing ring in its seated position, which prevents the possibility of high oil pressure pushing it out of its seated position.

The actual repair may take up to one hour; however additional time may be required depending upon the BMW dealer's schedule. This work will be performed <u>free of charge</u> by your authorized BMW motorcycle dealer.

If you are no longer the owner of this motorcycle, we would appreciate your furnishing us the name and address of the new owner using the enclosed postage-paid card.

If you have already had this repair performed at your own expense, please see the attachment regarding possible eligibility for reimbursement.
